NAEMSP® National EMS Medical Directors Course & Practicum®

Upon completion of the NAEMSP® National EMS Medical Directors Course & Practicum®, the participant will be able to:

- ◆ Define the terms prospective, concurrent and retrospective as they relate to quality management programs.
- ◆ Recognize legal considerations related to EMS systems and EMS medical oversight.
- ◆ Describe the EMS Medical Director's role in education and training of EMS personnel.
- ◆ Differentiate certification and credentialing of personnel from approval and accreditation of training programs or EMS agencies.
- ◆ Differentiate between certification and licensure for EMS providers.
- ◆ Outline the Incident Command System and describe the EMS component.
- ◆ Discuss the components and challenges in conducting prehospital research.
- ◆ Describe the organization of EMS services in the state.
- ◆ Recognize the impact of applicable state laws, rules and regulations on EMS medical oversight and the EMS medical director.
